As a former Chief Operating Officer and current Board Member of Valley Interior Systems, John has played a pivotal role in driving consistent growth, expanding operations to six locations, and fostering an exceptional company culture introduced initially by his father, Bill. Over the past decade, John has expanded his focus to workforce development and educating K-12 students about the opportunities the trades can provide, specifically with his leadership and mentoring of the CCAP program. His strategic vision, coupled with skills in business planning, stakeholder relations, and team development, has solidified his reputation as an innovative and results-driven professional.
